Bid Documents can be uplifted from the Finance Department, Ministry of Public Security, Lot 6 Stabroek, Georgetown upon payment of a non-refundable fee of three thousand (\$3,000.00) dollars in favour of the Permanent Secretary, Ministry of Public Security, for each Bid Document. The method of payment shall be in cash or Manager's Cheque.

Bids shall be submitted in a plain sealed envelope bearing no identification of the Bidder. Each envelope should state clearly the name of the project (**for example, 'Current Works – Renovation to Bachelors' Quarters, Sibley Hall Prison, Guyana Prison Service, Ministry of Public Security'**) at the top left hand corner.

Bids will be opened at **09:00 hours on Tuesday 17th October, 2017** in the Boardroom of the Ministerial Tender Board, Ministry of Public Security in the presence of those Bidders or their representatives who choose to attend the opening.

All Bids must be accompanied by valid Certificates of Compliance from the Manager of the National Insurance Scheme (NIS) and the Commissioner General of the Guyana Revenue Authority (GRA).

Each bid that exceeds fifteen million dollars (G\$3M) must be accompanied with bid securities as stated in bid Documents.

The Ministerial Tender Board, Ministry of Public Security reserves the right to reject any or all the Bids without assigning any reason whatsoever and not necessarily to award to the lowest Bid.
