This invitation for bids follows the General Procurement Notice for this project that appeared in Development Business, issue no. IDB990-07/16 of July 26, 2016.

The Government of Guyana has received financing from the Inter-American Development Bank toward the cost of the Citizen Security Strengthening Programme, and it intends to apply part of the proceeds of this financing to payments under the Contract for Procurement of Goods - *Supply, Delivery, Installation and Testing of Modification Parts for the Heat Ventilation and Air Conditioning (HVAC) System of the Guyana Forensic Science Laboratory.*

The PEU of the Citizen Security Strengthening Programme now invites sealed bids from eligible and qualified bidders for the Procurement of Goods – *Supply, Delivery, Installation and Testing of Modification Parts for the HVAC System of the Guyana Forensic Science Laboratory.*

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Inter-American Development Bank's policies for the Procurement of works and Goods GN-2349-9. and is open to all bidders for Eligible Source Countries as defined in the Policies.

Interested eligible bidders may obtain further information from the Procurement Officer, Citizen Security Strengthening Programme, Ministry of Public Security or by email at procurement.cssp@gmail.com, and inspect the bidding documents at the address given below from 08:00 hrs. to 15:00 hrs., Monday to Friday.

Qualification requirements include (but are not limited to): NIS and GRA Compliances (for Bidders registered in Guyana), Valid Business and VAT Registration (where applicable), experience, and financial and technical capacity. A margin of preference for certain goods manufactured domestically shall not be applied. Additional details are provided in the bidding documents. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of five thousand (Guyana) dollars. The method of payment will be cash or manager's or cashier's cheque payable to the Ministry of Public Security. The bidding documents can be uplifted from the address below (a) upon presentation of the receipt.

All bids must be accompanied by a Bid Security of 2% of the bid price in Guyana dollars or an equivalent amount in a freely convertible currency.

Bids must be delivered to the address below (b) on or before **Tuesday 15th August, 2017 at 09:00 hrs (9 am)**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened on **Tuesday, 15th August, 2017 at 09:00 hrs. (9 am)** at the address below (b) in the presence of the bidders or bidders' representatives and anyone who choose to attend.
