**DOCUMENTS REQUIRED**

1. A copy of the Certificate of Vehicle Registration and the Certificate of Fitness in respect of which the application for tint waiver is made.
2. A copy of the last tint permit received (if applicable).
3. The above mentioned Original Documents for verification.

**APPLICATION PROCESS FOR A TINT WAIVER**

The process from application to final approval or rejection for a tint waiver is as follows:

1. Upon receipt of the application, along with documents required, the applicant will be served with a letter that must be taken to the Licence Revenue Office (LRO) in order to verify the Vehicle's Tint Density.
2. Subsequent to the completion of this verification process, the Licence Revenue Office (LRO) will submit its Tint Reading to the Minister of Public Security for his approval/refusal.
3. The Ministry will notify the applicant of the final decision, and if the application is approved, the applicant will be granted a TINT WAIVER PERMIT.

**IMPORTANT**

1. Tint Waiver Permits are valid for one (1) year and should be renewed at least one (1) week before the expiry date.
2. The estimated processing time for an application is three (3) to five (5) working days.
3. Only vehicles with a MANUFACTURE'S TINT are eligible to be considered for a Tint Waiver.
